Celebrity Calf Dressing Rules and Entry Form

ENTRY FEE \$100/TEAM

All entry fees will be paid back and prize money will depend upon number of teams entered. If there are 4 teams for each of the 1<sup>st</sup> 2 nights, the top 2 from each night will come back for the finals on the last night and the top 2 teams will be winners. Teams per night will be limited to 8. 3 teams or less per night will have only 1 winner. This is a timed event.

ELIGIBILITY:

- All contestants must complete the Entry/Release form
- All contestants must wear long-sleeved shirts and blue jeans.

THE TEAM

- Teams will consist of no more than 4 adult members
- One member must be a female.
- Fee for participating is \$100 per team.

DRESSING PROCEDURES:

- Each time will be assigned a bucking chute.
- Calves will be turned out of chute with a halter and lead rope.
- One (1) member of the team will be allowed to stand on the outside of the chute gate.
- Three (3) members of the team will be behind a starting line 20' from the chutes and will not be allowed to cross the line until the calf is completely out of the chute.
- Bulldogging, pulling the tail and any other unnecessary roughness will not be allowed.

The members must dress the calf with the supplied boxer shorts, necktie and socks for hind feet. Boxers must be pulled all the way up with the tail out the slit.

- This is a timed event. Time will be stopped when flagger/judge indicates calf is dressed properly. Placings are determined by how fast the calf is properly dressed.
